Each resident or business may spot a truck up to 3 times in one calendar year. Our records indicate this is your (circle one): first/second/third track in the year 20\_\_.

Fee (Based on rentals within one calendar year):

**Owner Occupied Residential**

First truck-free

\$100 for the third truck

**Commercial/Rental Property/ Churches**

\$75 for the first truck  
\$100 for the second truck  
\$ 125 for the third truck

**We cannot accept:** MOTOR OIL, OLD TIRES, CAR BATTERIES, ANTIFREEZE, BRAKE FLUID, PAINT, SHINGLES, and HAZARDOUS SUBSTANCES, in addition, Lockland Code prohibits the collection of waste or rubble resulting from building demolition, remodeling, or construction. Anyone responsible for causing this waste must arrange for its disposal with a private collector.

**Conditional Items:** REFRIGERATORS, AIR CONDITIONERS, AND ANY OTHER ITEMS THAT CONTAIN FREON. Conditional items must have a certificate attached that the Freon has been removed and signed by a certified technician. Please note this is a Federal Law.

**Release of Liability**

In consideration of services to be rendered to the undersigned and other good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned hereby releases the Village of Lockland., OH and all its employees and agents (hereinafter the "Village") from any and all liability resulting or arising from entrance upon and work upon the premises known as: \_\_\_\_\_ whether or not such entrance and work are within the scope of their employment and agency relationship with the Village.

This release shall be binding upon the undersigned, their heirs, and assigns.

Furthermore, the undersigned property owner hereby accepts financial responsibility for 1) any and all damages that might be done to the Village owned vehicle during any period of time such vehicle is left at the premises of such owner, at his/her request and for his/her convenience, with the financial responsibility for such damage accruing regardless of whether the owner is directly responsible for this damage; and 2) for any assessments placed on the Village by a landfill for the disposal of any items taken from the premises known as: \_\_\_\_\_
