**INSTRUCTIONS FOR PAYING CITATIONS**

If you are charged with an offense that does not require court appearance, you may:

1. Pay online at [www.locklandoh.org](http://www.locklandoh.org)  
Search by your name only  
Payment must be paid by 3:00 p.m. on your assigned court date.
2. Appear personally at the Lockland Clerk of Courts Department by 3:00 p.m. on the assigned court date, signing the waiver printed on the citation and paying the fine. Accepted forms of payment are cash, Visa, MasterCard, check or money order.
3. Signing the waiver on the citation and mailing it and a check or money order for the fine to the **Traffic Violations Bureau** at the address listed above. Checks and Money Orders must be made payable to the **Village of Lockland**.

\*\*\*Payment must be **Received** by the assigned court date. If not received by 3:00 p.m. on the assigned court date, the defendant **must appear** in court.

**NOTE: US CURRENCY ONLY**

**FAILURE TO PAY THE INDICATED FINE BY YOUR COURT DATE OR TO APPEAR IN COURT ON THE COURT DATE LISTED ON YOUR CITATION WILL LEAD TO A WARRANT BEING ISSUED FOR YOUR ARREST AND SUSPENSION OF YOUR DRIVER'S LICENSE.**

Ohio state law requires proof of insurance. If financial responsibility proof shown is not marked "yes" on your citation, you will need to show proof of insurance at time of your payment. Insurance must be for the vehicle driven at the time of the offense.

If you do not show proof of your financial responsibility as of the date of the offense, the Bureau of Motor Vehicles will suspend your operator's license.

**When you appear in court you MUST pay
